NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Oneal Township,

near the Double Springs School, lying on the northern side of a surfacetreated road that leads from the Buncombe Road to the Greenville-Sandy Flat Road, bounded by lands now or formerly owned by J.T. Carlton, W.D. Tate, and others, having the fellowing courses and distances: Beginning on an iron pin on the eastern edge of a community road, the northwestern corner of the rtact, and runs thence with said road S.6.00 E. 59.5 feet to a stake in the said road; thence S. 74.45 E. 90 feet to a stake on the northern edge of the surface-treated road above mentioned; thence with the surface treated road S. 76.30 E. 110.6 feet to a point in said road on Dill line(stake on bank of the road); thence N. 4.00 E. 75 feet to an iron pin; thence N. 66.30 E. 483.5 feet to an iron pin on the eastern side of a small branch; thence M. 9.10 E. 106 feet to an iron pin; thence S. 67.30 W. 684 feet to the beginning corner, containing 1.75 acres, more or less, and being all of that property described in two deeds to me, the mortgagor, recorded in the R.M.C.
