"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being a portion of Boyce Addition, in the City of Greenville, being the Western portion of lot 4, Block 7, as shown on plat of Boyce Addition, recorded in Plat Book A at Page 179, and described as follows:

"BEGINNING at an iron pin on the South side of East North Street, corner of lot 3, of Block 7, and running thence with line of lot 3, S. 15 E. 126 feet 1 inch to an iron pin on a ten foot alley; thence with said alley, N. 76-45 E. 52 feet to an iron pin thence N. 15 W. 126 feet 1 inch to an iron pin on the South side of East North Street; thence with said North Street, S. 76-45 W. 52 feet to the beginning corner."
