MORTGAGE

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, being known and designated as Lot No. 4 as shown on plat of the property of Revalee Cartee, recorded in Plat Book X at Page 71, and being more particularly described according to said plat as fellows:

"Beginning at an iron pin on the eastern side of Nash Street, joint front corner of Lots Nos. 3 and 4, and running thence with joint line of said lots S. 70-53 E. 207.3 feet to an iron pin; thence S. 22-45 W. 150 feet to an iron pin; thence N. 70-53 W. 266.5 feet to an iron pin in the eastern side of Nash Street; thence with said Street N. 23-11 E. 150 feet to the point of beginning; being the same property conveyed to the mortgagors by Edgar Gillespie by deed to be recorded herewith."
