MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:
We, Claude E. Willis and Elsie A. Willis, of Greenville County, SEND GREETING WHEREAS, we the said Claude E. Willis and Elsie A. Willis
in and by our certain promissory note, in writing, of even date with these presents are well an truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the
full and just sum of Two Thousand, Two Hundred and No/100 (\$ 2,200.00 Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in installments of
Twenty-Two and No/100 (\$ 22.00) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at an time any portion of the principal or interest due thereunder shall be past due and unpaid for a perior of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holde thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); a in and by said note, reference being thereunto had, will more fully appear.
NOW KNOW ALL MEN, That we, the said Claude E. Willis and Elsie A. Willis

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to us,

the said Claude E. Willis and Elsie A. Willis in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, about 2-1/2 miles north of the City of Greenville in a section known as Sans Souci, and being known and designated as Lot No. 42 of a subdivision of the property of the Mountain View Land Company made by W. A. Adams and recorded in the R. M. C. office for Greenville County in Plat Book A, at pages 396 and 397, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the west side of Gridley Street at the corner of Lot No. 41, and running thence along the line of that lot, N. 89-1/2 W. 146 feet to an iron pin on a 10-foot alley; thence along the line of said alley, N. 11-1/2 W. 50 feet to an iron pin at the rear corner of Lot No. 43; thence along the line of that lot, S. 89-1/2 E 144 feet to an iron pin on the west side of Gridley Street; thence S. 13 E. 50 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.

"The above described lot is the same as conveyed to us by Mary L. Chandler by deed dated May 8th, 1944 and recorded in the R. M. C. office for Greenville County in Vol. 263, at page 329."
