NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, shown on plat of Riverside, recorded in Plat Book A at Page 323, and described as follows:

"Beginning at an iron pin on the north side of Cedar Lane Road, corner of the old street car line and the public street, lying east of Lot No. 24 of Block AA, and running thence with the northern side of Cedar Lane Road S. 79-57 E. 30 feet to iron pin; thence in a northerly direction 260 feet to a point on Colonia Avenue in the old street car line; thence with the southern side of Colonia Avenue N. 79-57 W. 30 feet to edge of public street; thence along the eastern side of Lot No. 12, Block AA, in a southerly direction 200 feet to the beginning corner."
