NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being shown and designated as lot No. 33 on plat of Hudson Acres, recorded in Plat Book Y at Page 39, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Eastern side of Greenwood Avenue, at the joint front corner of lots 32 and 33, and running thence with line of lot32, N. 84 E. 253.6 feet to iron pin; thence N. 4-45 W. 200.4 feet to iron pin, rear corner of lot 34; thence with line of lot 34, S. 84 W. 258.5 feet to iron pin on Greenwood Avenue; thence with the Eastern side of Greenwood Avenue, S. 6 E. 200 feet to the point of beginning."

Being the same premises conveyed to the mortgagor by deed recorded in Book of Deeds 466 at Page 385.

ALSO, All that other lot of land adjacent to the lot first above described and being more particularly described by metes and bounds as follows:

BEGINNING at an iron pin and running thence S. 4-45 E. 136.4 feet; thence S. 74-18 E. 323.3 feet; thence N. 11-55 W. 309.9 feet; thence N. 83 W. 263.3 feet to pin in rear line of lot 33; thence S. 4-45 E. 95.7 feet to the beginning corner.
