NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and ruly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 15.25 acres, in Chick Springs Township, on the Northern side of U. S. Highway 29 and being shown as tract 1 on plat of the property of the B. F. Flynn Estate, recorded in Plat Book BB at Page 143 and having according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin on the Northern side of U.S. Highway 29 at the joint corner of tracts 1 and 2 and running thence with line of Lot 2 N. 15-55 W. 1006 feet to pin; thence S. 37-00 W. 1362 feet to pin; thence with the line of the property of J.
