SEND GREETING:

WHEREAS, Carl D. Barnette in and by certain promissory note in writing of even date with these Presents, well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of Twelve hundred and no/100 - - - - - - - (\$) Dollars, with interest from the date hereof at the rate of **seven** per cent (7 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of Nineteen and 20/100 - - - - - - - - - - (\$) dollars due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any, incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

KNOW ALL MEN BY THESE PRESENTS, That I the said

Garl D. Barnette , in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said Citizens Building & Loan Association, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Highland Township, lying on the South side of road that leads from Evenezer Baptist Church to Gowansville, near said Church, bounded by lands of minnie Farmer Estate, Milton Sudduth, Mrs. Hugh Dill and John Campbell Estate, having the following courses and distances:

BEGINNING on a stone on the North side of a gully, corner with Minnie Farmer Estate lands, and runs thence with line of this property to a stone, corner with John Campbell Estate lands and others; thence with line of Talmadge Campbell, formerly the Edwards line to center of the road leading from Ebenezer Baptist Church to Gowansville; thence with the road as the line to a stake in said road, corner with Dill and Sudduth; thence S. 28.30 E. 289 feet to the beginning corner, containing 20 acres, more or less.
