(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Seven Thousand and No/100

DOLLARS (\$7,000.00), with interest thereon from date at the rate of five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, at the intersection of Ottaray Drive and Lanneau Drive, and being known and designated as Lot No. 21, as shown on a plat of Lanneau Drive Highlands, recorded in Plat Book "D", at Pages 288 and 289, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin in the East side of Ottaray Drive, joint front corner of Lots No. 21 and 21, and running thence with Ottaray Drive, N. 26-13 W. 18.2 feet to a point at the intersection of Lanneau Drive; thence with the East side of Lanneau Drive, N. 10-11 E. 39.5 feet to an iron pin corner of Lot No. 20; thence with line of said lot, N. 63-47 E. 126.5 feet to an iron pin rear corner of Lot No. 13; thence with line of said lot, S. 26-13 E. 50 feet to an iron pin rear corner of Lot No. 22; thence with line of said lot, S. 63-47 W. 150 feet to the point of beginning."
