in and by our certain promissory note, in writing, of even date with these presents are well and truly indebted to **FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE**, in the

full and just sum of Five Thousand and No/100 - - - - - (\$ 5,000.00)
Dollars, with interest at the rate of ^{five (5%)} ~~six (6%)~~ per centum per annum, to be repaid in installments of

Funk, Chairman of the Board of Deacons in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said **FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE**, according to the terms of said note, and also in consideration of the further sum of Three Dollars to us , Emmanuel Baptist Church, by Jack Ward, Pastor and Charlie W. "BEGINNING at an iron pipe on Mission Street, corner of Lot No. 6 and running thence with Mission Street, N. 36-51 W. 60 feet to an iron pipe corner of Lot No. 6; thence with joint line of Lot No. 4, N. 53-18 E. 200 feet to an iron pipe on line of Lot No. 3; thence with joint line of Lot No. 3, S. 36-50 E. 60 feet to an iron pipe corner of Lot No. 6; thence with line of Lot No. 6, S. 53-18 W. 200 feet to an iron pipe on Mission Street, the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same property conveyed to Emmanuel Baptist Church by Jane G. Hammond by her deed dated August 7, 1934 and recorded in the R. M. C. office for Greenville County in Vol. 172, at page 305."
