NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the Northwest corner of Dukeland and Merriweather Streets, near the City of Greenville, being shown as Lot No. 54 on Plat of property of Ethyl Y. Perry, made by W. J. Riddle, in June, 1951, recorded in Plat Book BB at Page 39 and described as follows:

BEGINNING at a stake on the Northwest corner of Dukeland Drive on Merriweather Street and running thence with the Western side of Merriweather Street N. 21-25 W. 125.8 feet to a stake; thence S. 65-11 W. 81.5 feet to a stake; thence S. 35-42 E. 137 feet to a stake on Dukeland Drive; thence with the Northern side of Dukeland Drive N. 54-18 E. 50 feet to the beginning corner.

Being the same property conveyed by W. James Williams by deed recorded.
