anticipating any part or all of said payment, payments to be applied  
first to interest and then to principal  
with interest thereon from date

at the rate of 6 per centum per annum, to be computed and paid quarterly  
until paid in full: all interest not paid when due to bear  
interest at same rate as principal: and if any portion of principal or interest be at any time past due and unpaid,
