Phillips, his heirs and assigns forever, all that piece, parcel, or lot of land, situate, lying and being on the North side of Durham Street, just outside the City Limits of the City of Greenville, Greenville County, South Carolina, being known and designated as Lot No. 2 on a Plat of Property owned by Central Realty Corporation, made by Pickell & Pickell, June 20, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book "B" at page 199, and having according to said plat the following metes and bounds, to-wit:
