C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) the said mortgagor in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, lying on the East side of the Pelham Road leading from Pleasant Grove Church to Pelham, containing eight and five-tenths (8.5) acres, more or less, designated as tract No. 2 on a plat of the property of S. R. Smith Estate by H. L. Dunahoo, dated July 25,1949, and having the following courses and distances, to wit:-

nail in the center of the road, corner of Gordon Smith land, and running thence N. 60.00 E. 725 feet to an iron pin, corner of tract no. 1; thence S 88.00 E. 459 feet to a stake on line of Hollingsworth land; thence S. 3.20 W. 400 feet to an iron pin, corner of tract no. 3; thence S. 88.00 W. 709 feet to an iron pin at intersection of two branches; thence down the branch as a line, S. 64.30 W. 360 feet to a nail in center of road; theme along the center of said road as a line, N. 3.50 W. 229 feet to the beginning corner.
