NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of McCall Street in the City of Greenville, being lot No. 5 and a lot designated as "J.R. Ware" on plat of the Estate of J. H. Ware, made by R. E. Dalton in November, 1919, recorded in Plat Book E at Page 264 and described as follows:

BEGINNING at a stake on the Western side of McCall Street 124.5 feet North from Rhett Street at corner of Lot 6; and running thence with the Western side of McCall Street N. 18-49 W. 133 feet to a stake at corner of Lot 1; thence with the line of said lot S. 70-52 W. 100.9 feet to a stake in line of Lot 3; thence with the line of Lots 3 and 4 S. 18-49 E. 68 feet to a stake; thence continuing with the line of lot 4 S. 18-16 E. 51.3 feet to a stake; thence S. 18-45 E. 13 feet to a stake in line of lot 7; thence with the line of Lots 7 and 6 N. 71-15 E. 101.5 feet to the beginning corner.
