C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to us the said mortgagor s in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained,

sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, School District 286, about three miles West of the City of Greer, lying West of the Hammett Bridge Road and immediately North of the Holliday-Foster Road, and being a portion of Tract No. 9 on a plat of the John C. Greer Estate, and having the following courses and distances, to wit:-

BEGINNING on a pin in center of the Holliday-Foster Road, cornering with Tract No. 8 (said point being about 925 feet Northwest of the junction of the Hammett Bridge Road with the Holliday-Foster Road), and running thence along the line of Tract No. 8, N 27-30 W one thousand one hundred two (1102) feet to a stake or iron pin in a branch, cornering with property of Perry Littlefield; thence with the line of Perry Littlefield, N 85-00 W one hundred seventy-four (174) feet to a stake or iron pin; thence continuing with line of Little-S 23-30 E nine hundred sixty-seven (967) feet to a stake or iron pin on Northern edge of Holliday-Foster Road; thence with the center of said road, S 69-30 E two hundred eighty-five (285) feet to the point of beginning, containing h.03 acres, more or less.
