Fighwat No. 81, and runs thence with the common line of these lots S. 12.00 W. 175 feet to an iron pin; thence N. 78 W. 70 feet to an iron pin, corner of Lot No. 79; thence with the common line of Lots Nos. 79 and 80 N. 12.00 E. 175 feet to an iron pin on the South side of Leaf roinsett Drive, formerly old U. S. Highway No. 29; thence therewith S. 78.00 F. 70 feet to the beginning corner, and being all of that lot as conveyed to C. B. & Wilda S. Pollifield, by Deed dated Nov. 12, 1951, recorded in Deed Book 445, at 1826 471.
