full and just sum of Fourteen Thousand, Two Hundred and No/100(\$ 14,200.00 )  five (5%)  Dollars, with interest at the rate of six/6%) per centum per annum, to be repaid in installments of

"BEGINNING at an iron pin on the northern side of Sanford Court, the joint front corner of Lots 16 and 17, and running thence along the joint line of said lots, N. 25-05 W. 166.6 feet to an iron pin in line of Lot 15; thence along the line of Lot 15, S. 80-41 W. 109.9 feet to an iron pin on the eastern side of a 36-foot access road; thence along said road, S. 12-18 E. 100 feet to an iron pin; thence continuing with said road, S. 26-30 E. 93.5 feet to an iron pin at the intersection of said access road with Sanford Court; thence along Sanford Court, N. 67-22 E. 126 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
