All that piece, parcel or lot of land in Highland Township, State and County aforesaid, located about one mile Northeast from Lenoah School, lying on the East side of the road that leads from Lenoah School to the Pleasant Hill Community, being bounded on the North by lands of Johnson on the East by a branch and lands of Wilson Roe, on the South by two small tracts being conveyed this day by Doyle C. Poole to the grantor and grantee herein, and on the West by the said road, and having been pruchased in two separate tracts of 11.2 acres and 7.2 acres, making a total of 18.4 acres, more or less, and having the following courses and distances, to wit:-
