WHEREAS Walter Jones and wife, Annie (a/k/a Anna) Mae Jones, hereinafter referred to as first party (whether one or more persons) is indebted to M.M.Karr, d/b/a Interstate Roofing and Siding Company, herein after referred to as second party, for repairs and improvements to the hereinafter described property pursuant to contract, the complete performance of which by second party is hereby acknowledged by first party, in the sum of One Thousand, One Hundred Forty-Nine and 48/100 -- (\$1,149.48) Dollars, for which first party has executed and delivered to second party his note in said amount, of even date herewith, payable in monthly installments of 31.93 Dollars on the 5 day of each month hereafter until the said indebtedness shall be fully paid, with interest from maturity at 6% per annum, as in and by the said note, reference thereunto being had, will more fully appear.

NOW, KNOW ALL MEN, that in consideration of the premises and for the better securing the payment of said debt according to the conditions of said note and also in consideration of \$3.00 paid by second party to first party, receipt of which is hereby acknowledged, first party has granted, bargained, sold and released and by these presents does grant, bargain, sell and release to second party, his heirs and assigns, all that certain lot of land, together with the improvements thereon, situated in or near the

City of Greenville, County of Greenville State of South Carolina, fronting 40 feet on Joe Louis Avenue (Being Northeastern one-half of Lot #16 of Arnold Place, owned and occupied by Walter Jones and Anna Mae Jones being approximately 81.44 feet in depth, and being known as

to first party, dated February 10th, 19 50, and recorded in the office of the Clerk of Court for Greenville County

in Deed Book 402 at page 206, together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining; to have and to hold all and singular the said premises unto the said second party, his heirs and assigns, forever; and first party hereby binds himself and his heirs, executors and administrators to warrant and forever defend all and singular the said premises unto second party, his heirs and assigns, from and against himself and his heirs, executors, administrators, assigns, and all other persons whomsoever lawfully claiming or to claim the same or any part thereof.

And it is agreed by and between the said parties that in case of default in payment of any installments as herein provided the whole amount of the debt secured by this mortgage shall immediately become due and payable at once, and that in case of foreclosure of this mortgage the second party shall recover of the first party a reasonable sum as attorney's fee, which shall be secured by this mortgage and shall be included in judgment of foreclosure.

PROVIDED ALWAYS, NEVERTHELESS, if the first party shall pay the aforesaid debt, with interest thereon, if any be due, according to the terms of said note, then this mortgage shall be utterly null and void.
