WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Dime Street, in the City of Greenville, in the City of Greenville, in the Section known as Nicholtown, being shown as Lot No. 4 of Block 1, Page 201 of the County Block Book and described as follows:

BEGINNING at a stake on the Southern side of Dime Street 172 feet West from Rebecca Street (sometimes known as Cook Avenue) at corner of Lot now or formerly owned by Textile Real Estate Company and running thence with the line of said lot approximately due South 69.5 feet to a stake; thence approximately S. 60 W. 78.5 feet to a stake at corner of lot this day conveyed to Fred L.
