"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the East side of Watson Road, near the City of Greenville, shown as Lot 87 of Block "A" on Plat of Orchard Acres, made by Piedmont Engineering Service, November 20, 1953, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "BB", page 103; said lot fronting 100 feet along the East side of Watson Road and running back to a death of 200 feet on the South side, to a depth of 207 feet on the North side, and being 70 feet across the rear.
