per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the Town of Fountain Inn on the Northside of the Jones Mill Road with the following metes and bounds according to a plat and survey made by E. E. Gary, Surveyor, June 14, 1949; Beginning at an iron pin on the Northside of said Jones Mill Road, in the edge of said road, joint front corner with lands of Floyd and Mary W. Weathers, and running thence with said road S. 17-1/2 W., 80 feet to an iron pin, corner of other lands of said Floyd and Mary W. Weathers; running thence N. 72 1/2 W., 150 feet to an iron pin; thence N. 17 1/2 E., 104 feet to an iron pin; thence S. 62 1/4 E., 152 feet to an iron pin, the point of beginning, and bounded by lands of Floyd and Mary W. Weathers and the Jones Mill Road."
