

ALL that certain piece, parcel or lot of land, and the improvements thereon, situate, lying and being in the State and County aforesaid, Chick Springs Township, near the Town of Greer, S. C., lying on the east side of the Jones Road, being bounded on the east by lands formerly of Geanie Caldwell, being the same lot of land that was conveyed to me by deed from Lloyd E. Hunt, said deed recorded in the office of the R. M. C. for Greenville County in Deed Book 459 at page 213, and having the following courses and distances, to wit:-

Beginning at a point in the center of the said road, joint corner of the lot for the former Dan D. Davenport lot, and runs thence with the line of the same lot, S.81-00 E. 18 feet to an iron pin on the east bank of the roadand on the original line of the lot; thence S/89-30 E. 161.8 feet to an iron pin on the former Caldwell line and on the north edge of a proposed new road; thence with the Caldwell lineN. 2-44 | E. 115 feet to an iron pin, new corner; thence S. 85-00 W. 200 feet to a point in the center of the said road (iron pin back on line at 16.6 feet); thence with the center of the said road S. 9-30 E. 92 feet to the
