or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW-ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, Tax District 235, and being known and designated as Lots Nos. 5, 6, 7, 8, 9, 12 and 13, of a subdivision of the property of Susan Fortune as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book U, at page 159, and having such metes and bounds, courses and distances as shown thereon, reference thereunto being had. Lots Nos. 5, 6, 7, 8 and 9 being described in the aggregate as follows:

"BEGINNING at an iron pin at the northwest corner of the intersection of Fortune Street with a 20-foot alley, running parallel with Green Avenue Extension, and running thence along the northwest side of said alley, S. 34-08 W. 98.6 feet to an iron pin in line of property of Dunean Mill; thence along the line of the Dunean Mill property, N. 28-27 W. 373.9 feet, more or less, to an iron pin at the southeast side of Fortune Street; thence along the line of Fortune Street, N. 72-28 E. 75.1 feet to an iron pin at a right angle turn in Fortune Street; thence along the southwest side of Fortune Street, S. 30-59 E. 314.6 feet to the beginning corner.

LOTS NOS. 12 and 13 being described in the aggregate as follows: "BEGINNING at an iron pin at the northeast corner of the intersection of Fortune Street with a 20-foot alley, and running thence along the northeast side of Fortune Street, N. 30-59 W. 151 feet to an iron pin at the corner of Lot No. 11; thence along the line of that lot, N. 59-01 E. 92.9 feet to an iron pin; thence S. 28-05 E. 111.6 feet to an iron pin at the intersection of said alley; thence along the northwest side of said alley, S. 34-08 W. 96 feet to the beginning corner.
