All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being at the Northerly corner of the intersection of East Avondale Drive and North Avondale Drive, and being designated as a portion of Lot No. 4. Block C. on the plat of Utopian Development Company and recorded in the RID Office for Greenville County, S. C. in Plat Book "G", pages 135 and 136, and having according to a more recent survey entitled "Property of Ethel Harris Quinn" made by Delton & Neves, October 1953, and recorded in Plat Book HH, page 115, the following metes and bounds, to-wit:

Beginning at an iron pin on the Northerly side of East Avondale Drive, which iron pin is located 200 feet from the Northeasterly corner of the intersection of East Avondale Drive and North Main Street, and also being the joint corner of Lots Nos. 1 and 4. Block C. and running thence along the Northerly side of East Avondale Drive, the following courses and distances: S 66-47 E 50 feet to an iron pin; S 56-43 E 50 feet to an iron pin; S 43-38 E 60 feet to an iron pin to the corner of East Avondale Drive and North Avondale Drive; thence around said corner on a curve, the chord of which is N 70-41 E 26.8 feet to an iron pin on the Westerly side of North Avondale Drive: Thence along the Vesterly side of North Avondale Drive N 20-29 E 116.3 feet to an iron pin: thence on a line projecting into Lot No. 4 N 74-23 W 134.1 feet to an iron pin; thence S 15-37 W 10 feet to an iron pin; thence N 74-23 W 54.9 feet to an iron pin, joint corner of Lots Nos. 1, 2 and part of Lot No. 4, Block C; thence along the rear line of Lot No. 1 S 10-13 W 79 feet to an iron pin on the Northerly side of East Avondale Drive, the point of beginning.
