TO ALL WHOM THESE PRESENTS MAY CONCERN: Union Baptist Church

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Seventeen Hundred Fifty and $\frac{N}{100}$
DOLLARS (\$1,750.00), with interest thereon from date at the rate of Six (6%)
per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying near the Park Street Road, containing 3.11 acres, and having according to the Plat of C. E. Jones, made February 18, 1954, the following metes and bounds, to-wit:

"BEGINNING at a point, the joint corner of Willimon and Tucker lands and running thence with the line of the Tucker land S. 39-42 W. 77 feet; thence continuing S. 39-42 W. 328 feet to pin; thence S. 50-00 W. 157.6 feet to iron pin at the corner of land now or formerly owned by E. E. Ashmore; thence with the line of Ashmore S. 23-45 W. 159.8 feet to pin; thence continuing N. 23-45 W. 85.1 feet to pin; thence with the line of land now or formerly owned by J. H. Brown N. 20-15 W. 378.4 feet to pin, near large poplar; thence with the line of the property, now or formerly owned by the Estate of E. C. Willimon S. 61-56 E. 360.6 feet to iron pin; thence continuing S. 61-56 E. 282 feet to the point of beginning."
