Local Home Builders, Inc. with its principal place of business in Greenville, South Carolina

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Seven Thousand, Five Hundred and No/100-----

(\$.7,500.00) Dollars, with interest at the rate specified in said note, to be repaid in installments of

Seventy-Five and No/100-----(\$75.00 Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

C. Jones, C. E., April, 1954, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNENG at an iron pin on the Eastern side of Heard Drive, joint front corner Lots No. 42 and 43, and running thence with the joint line for said lots N. 62-53 E. 193 feet to an iron pin in the center of a branch; thence following the meanderings of said branch, the traverse lines of which are S. 36-20 E. 56.4 feet to an iron pin; thence S. 22-5 E. 79.2 feet to an iron pin, joint rear corner lots 13 and 14; thence with the joint line of said lots S. 71-50 W. 201 feet to an Iron pin on the Eastern side of Heard Drive; thence with said drive N. 23-00 W. 41.1 feet to an iron pin; thence continuing with said drive N. 27-07 W. 58.9 feet to the beginning corner; and being a portion of the same property conveyed to me by Henry J. Winn by Deed dated February 4, 1953, recorded in the R. M. C. office for Greenville County, Deed Volumn 471 at Page 382.
