WHEREAS I, James W. Skelton, am

well and truly indebted to

Betty M. Jackson, John P. Mann and Thomas C. Mann

in the full and just sum of Nine Hundred Eighty-Five and 50/100 - -

Dollars, in and by my certain promissory note in writing of even date herewith, due and payable

on or before January 2, 1955,

with interest from November 11, 1954 at the rate of six (6%) per centum per annum until paid; interest to be computed and paid semi-annually and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said James W. Skelton,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Betty M. Jackson, John P. Mann and Thomas C. Mann, their Heirs and Assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina, on the East side of Twin Springs Drive, being Lot No. 82 on a Plat of property of Pecan Terrace recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "GG", page 9, and being more particularly described as follows, to-wit:

BEGINNING at an iron pin on the East side of Twin Springs Drive, at the joint front corner of Lots Nos. 81 and 82, and running thence with the joint line of said lots, N. 64-34 E. 156 feet to an iron pin on the right-of-way line of the Air Base Railway Siding; thence with said right-of-way line, S. 25-26 E. 70 feet to an iron pin, corner of Lot No. 83; thence with the line of said lot, S. 64-34 W. 150 feet to an iron pin on Twin Springs Drive; thence with said Drive, N. 30-25 W. 70.2 feet to the beginning corner.
