To All Whom These Presents May Concern:

I, A. O. Robinson, of Greenville County,

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN
VILLE, in the full and just sum of One Thousand, Five Hundred and No/100 - - - - - (\$ 15.00)

Dollars, with interest at the rate specified in said note, to be repaid in installments of Fifteen and No/100 - - - - - - - - - (\$ 15.00)

Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and forcelose this mortgage said note further providing for ten (10%) per centum attemptions.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about two miles west of Greer on the north side of the old No. 8 National Highway, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin in the center of the highway on Lillian Smith's line, and running thence N. 51-30 W. 329 feet to an iron pin at Smith's corner; thence continuing with Smith's line, N. 72-15 W. 560 feet to an iron pin at Smith's corner; thence S. 38-30 W. 480 feet to an iron pin; thence S. 76 E. 467 feet to a stone; thence S. 74-15 E. 389 feet to a stone at H. Payne's corner; thence S. 73 E. 82 feet to the center of the highway; thence N. 36-45 E. 334 feet along said highway to the beginning corner, containing 8.39 acres, more or less; being the same conveyed to me by C. P. Holcombe by deed dated August 13, 1943 and recorded in the R. M. C. office for Greenville County in Deed Vol. 255, at page 403."
