MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Louis Thompson, of Greenville County,

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Seven Thousand, Two Hundred, Fifty and No/100 - - - -

(\$ 7,250.00 ) Dollars, with interest at the rate specified in said note, to be repaid in installments of Forty-Five and 88/100 - - - - - (\$ 45.88 )

Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, known and designated as Lot No. 9 on plat of Carver Park Addition made by the Piedmont Engineering Service, February, 1953, and recorded in the R. M. C. office for Greenville County in Plat Book DD, page 71, and having, according to said plat, the following courses and distances, to-wit:

"BEGINNING at an iron pin on Tuskegee Avenue joint front corner of Lots 8 and 9 and running thence along the line of Lot No. 8, N. 52-53 E. 105.4 feet to an iron pin; thence S. 22-02 E. 73.4 feet to an iron pin corner of Lot No. 10; thence along the line of Lot No. 10, S. 65-55 W. 94 feet to an iron pin on Tuskegee Avenue; thence along Tuskegee Avenue, N. 31-02 W. 50 feet to the beginning corner.

ALSO: "A small piece of land, triangular in shape, adjacent to the rear of Lot No. 9, hereinabove described, and constituting a portion of the area shown on plat of Carver Park Addition as "reserved by owner", and having the following courses and distances:

"BEGINNING at an iron pin, joint rear corner of Lots 9 and 10, of Carver Park Addition, and running thence along the rear line of Lot No. 9, N. 22-02 W. 73.4 feet; thence S. 36-54 E. approximately 75 feet; thence S. 65-55 W. approximately 20 feet to the beginning corner."

The above described property is the same conveyed to me by G. Dewey Oxner by deed dated September 28, 1954, not yet recorded.

This mortgage also covers the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.

This is a purchase money mortgage and all the proceeds of this mortgage loan were used for the construction of a house on the lot described herein and for the purchase of the above described lot on which said house was constructed.
