TO ALL WHOM THESE PRESENTS MAY CONCERN:

H. P. ASAY, JR. (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto THE FIRST NATIONAL BANK OF GREENVILLE, SOUTH CAROLINA, as Trustee Under Trust Agreement between F. W. Symmes and The First National Bank of Greenville, S. C. dtd. 5/6/47. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Fifteen Hundred and no/100 - - - - DOLLARS (\$ 1500.00)
with interest thereon from date at the rate of five per centum per annum, said principal and interest to be repaid: In monthly installments of \$24.16 on the 6th day of each month hereafter, beginning November 6, 1954, to be applied first to interest then to principal until paid in full, the unpaid balance in any event to be paid October 6, 1960.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Cleveland Township, being shown as Lot No. 233 on Map No. 2 of Pioneer Park made by Dalton & Neves in March, 1926, recorded in Plat Book G at Page 82, and described as follows:

"BEGINNING at a stake on the Eastern side of Lake Drive at corner of Lot 234 and running thence with the line of said Lot N. 61-15 E. 162 feet to a stake; thence N. 27-34 W. 95 feet to a stake at corner of Lot 232; thence with the line of said lot S. 63-02 W. 156 feet to a stake on Lake Drive; thence with the Eastern side of Lake Drive S. 24-10 E. 100 feet to the beginning corner."

Being the same property conveyed to the mortgagor by deed recorded in Deed Book 457, at Page 311.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
