MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Mary E. Braggs, of Greenville County, South Carolina

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of One Thousand, Four Hundred, Fifty and No/100 - - -

(\$\frac{1,450.00}{2}\) Dollars, with interest at the rate specified in said note, to be repaid in installments of

Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Paris Mountain Township, on the western side of Hunt's Bridge Road at the northwestern corner of the intersection of said Hunt's Bridge Road and the White Horse Road, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin at the corner of property of Keller, and running thence with Hunt's Bridge Road, S. 1-51 W. 70 feet to a stake where the western line on Hunt's Bridge Road intersects with the western line of White Horse Road; thence with the White Horse Road, S. 17-36 W. 5 feet to a point, corner of other property of Harvey D. and Mary B. Long; thence along the line of the Long property in a westerly direction 355 feet, more or less, to a elm tree at the corner of the Keller property, thence along Keller's line, N. 78-51 E. 371.5 feet to the beginning corner, including all plumbing, electrical amd heating fixtures now located on said premises, which are hereby expressly agreed to be a part of the realty."

The above described lot is the same as conveyed to me by the First Federal Savings and Loan Association of Greenville by deed recorded in the R. M. C. office for Greenville County simultaneously with this mortgage.
