WHEREAS, the Mortgagor is well and truly indebted unto

C. DOUGLAS WILSON & CO.

, a corporation
organized and existing under the laws of South Carolina, hereinafter
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which
are incorporated herein by reference, in the principal sum of TWELVE THOUSAND TWO HUNDRED
Dollars (\$ 12,200.00), with interest from date at the rate of Four & one-half per centum
(4½ %) per annum until paid, said principal and interest being payable at the office of C. Douglas
Wilson & Co. in Greenville, South Carolina,
or at such other place as the holder of the note may designate in writing, in monthly installments of
Seventy-seven and 23/100 -----Dollars (\$ 77.23),
commencing on the first day of December, 19 54, and on the first day of each month there-
after until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of November, 19 74.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina: BEING all that lot of land with the buildings and
improvements thereon, situate in the City of Greenville, being shown
as the front portion of Lot 35 on plat of Park Hill (combined plats
Nos. 2 and 3) made by R. E. Dalton, Engineer, November, 1936, recorded
in the R. M. C. Office for Greenville County, S. C., in Plat Book I,
at Pages 36 and 37; said plat fronting 72 feet along the Northwest side
of West Faris Road and running back to a depth of 201.8 feet on the
Northeast side, to a depth of 204.2 feet on the Southwest side, and
being 61.9 feet across the rear.

This is the same property conveyed to the mortgagor herein by deed of
even date, to be recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
