(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **One Thousand Two Hundred and No/100 - - -**

**DOLLARS (\$ 1200.00**), with interest thereon from date at the rate of **six (6%)** per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Woodruff Road in Butler Township, containing 6 acres, more or less, and being more particularly described by metes and bounds as follows:

"BEGINNING at an iron pin on the Southern side of Woodruff Road at the corner of the property now or formerly owned by Gladys S. Hines, and running thence with line of said property S. 2 W. 335 feet to pin; thence S. 83-47 W. 49.8 feet to iron pin; thence S. 2 W. 799.2 feet to iron pin; thence N. 62 E. 397.8 feet to iron pin; thence N. 117 E. 578.6 feet to iron pin; thence along the line of property of Agnes S. Boling N. 14-42 E. to iron pin at corner of lot shown as 25.1, Block 1, Page 260 of the Block Book; thence with rear line of said lot N. 83-30 W. 87 feet to pin; thence N. 14-42 W. 240 feet to iron pin on the Woodruff Road; thence with the Southern side of Woodruff Road N. 83-30 W. 98 feet to the point of beginning."

Said premises being shown as Lots 23 and 25 of Block 1, Page 260 of the County Block Book, and being a portion of the property conveyed to the mortgagor by deed recorded in Deed Book 248 at Page 248.
