"BEGINNING at an iron pin on the western side of West Dorchester Boulevard, joint front corner of Lots 172 and 173, and running thence with the joint line of said lots, S. 83-16 W. 155.3 feet to an iron pin; thence S. 6-44 E. 105 feet to an iron pin in the center of the rear line of Lot No. 171; thence with a new line through the middle of Lot No. 171, N. 83-16 E. 153.4 feet, more or less, to an iron pin on the western side of West Dorchester Boulevard; thence with said boulevard, N. 5-38 W. 105 feet to the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
