We, Harold H. Garrison and Louise H. Garrison, of Greenville County,

WHEREAS I/we the aforesaid mortgagor(s) in and by my/our certain promissory note in writing of any data with

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, and being known and designated as Lot No. 3 of a subdivision known as Avice-Dale as shown on plat thereof prepared by W. J. Riddle in November, 1954 and recorded in the R. M. C. office for Greenville County, S. C. in Plat Book B, at page 53, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northwestern side of Avice-Dale Drive at the joint front corner of Lots 3 and 4, and running thence along the northwestern side of Avice-Dale Drive, N. 28-45 E. 70.3 feet to an iron pin; thence continuing along the northwestern side of Avice-Dale Drive, N. 25-15 E. 199.5 feet to an iron pin; thence continuing along the northwestern side of Avice-Dale Drive, N. 22-30 E. 163.4 feet to an iron pin at the corner of Lot No. 2; thence along the line of Lot No. 2, N. 63-45 W. 488.5 feet to an iron pin; thence S. 28-30 W. 439 feet to an iron pin at the rear corner of Lot No. 4; thence along the line of Lot No. 4, S. 64-00 E. 518 feet to the beginning corner, containing 4.92 acres; being the same property conveyed to us by Avice W. Looper by deed dated November 5, 1946 and recorded in the R. M. C. office for Greenville County in Vol. 301, at page 412."
