NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lot 85, Section 6 as shown on a plat of the Judson Mills Village recorded in Plat Book "K" at Page 106, and being also known and designated as No. 20 Third Street, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin in the eastern side of Third Street joint front corner of Lots 84 and 85 and running thence with the line of Lot 84 N. 88-11 E. 76.58 feet to an iron pin at the rear corner of Lots 80 and 81; thence with the line of Lot 80 S. 1-50 E. 70 feet to the corner of Lots 79, 80, 85 and 86; thence with the line of Lot 86 S. 88-11 W. 76.51 feet to an iron pin in the eastern side of Third Street; thence with said street N. 1-53 W. 70 feet to the point of beginning."
