All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in the City of Creenville, being known and designated as Lot No. 2 of the property of Ollie J. Duncan, as seem on the thereof made by Dalton & Neves in July of 1945, recorded in the R. H. C. Office for creenville County, S. C. in Plat Book "R", page 179, and having, according to said plat, the following metes and bounds, to-wit:
