Ernest C. Fuller & Velma H. Fuller (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Ansel W. Johnson

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Sixteen Hundred and No/100 - - - - DOLLARS (\$ 1600.00),
with interest thereon from date at the rate of five (5) per centum per annum, said principal and interest to be repaid: in monthly installments of \$85.00 each on the first day of each month hereafter with interest thereon from date at the rate of five (5%) per cent, per annum, to be computed and paid semi-annually until paid in full.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southeast side of Super Highway leading from Greenville to Spartanburg, U. S. Highway No. 29, being shown as lot No. 22 on plat of Estate of Vance Edwards, recorded in Plat Book F at Pages 128 and 129, and described as follows:

"BEGINNING at an iron pin on the Southeast side of Super Highway No. 29, corner of lot 22, and lot 23, and thence with line of said lots, S. 47-08 E. 208.7 feet to iron pin; thence S. 42-52 W. 135 feet to iron pin, corner of lot 21, thence with line of lot 21, N. 47-08 W. 208.7 feet to an iron pin on Super Highway No. 29; thence with the Southeast side of Super Highway No. 29, N. 42-52 E. 135 feet to the beginning corner."

It is understood and agreed that this mortgage is junior in lien to a mortgage executed this day to Fidelity Federal Savings & Loan Association in the original sum of \$8000.00.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
