with interest from date at the rate of Seven (7%) per centum per annum until paid; interest to be computed and paid annually and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Z. V. Christy in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said E. L. Craigo, his heirs and assigns forever,

ALL those two certain lots of land situate, lying and being in the County of Greenville, State of South Carolina, a short distance West of the City of Greenville, known and designated as Lots Nos. 10 and 12 of Sunnyslope, according to a plat thereof made by R. E. Dalton in May 1919 and recorded in the RMC Office for Greenville County in Plat Book "F", at page 86 and having, according to said plat, the following metes and bounds:

BEGINNING at a stake on the West side of Zarline Street, 202 feet Southward from Fortner Street on the Southeast corner of Lot No. 8 and running thence with line of that lot, North 80-12 West 150 feet to a stake on joint corner of Lots Nos. 7, 8, 9 and 10; thence South 9-48 West 103 feet to a stake on joint corner of Lots Nos. 11, 12, 13 and 14; thence South 80-12 East 150 feet along line of Lot No. 14 to a stake on the West side of Zarline Street; thence along said Street, North 9-48 East 103 feet to the beginning corner.
