Dollars (\$ 10,000.00), with interest from date at the rate of four & one-half per centum (4 1/2 %) per annum until paid, said principal and interest being payable at the office of Fidelity Federal Savings & Loan Association in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Sixty-three and 27/100

Dollars (\$ 63.27), commencing on the first day of February, 1955, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of January, 1975.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville State of South Carolina;

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, being known and designated as Lot 103 as shown on plat of College Heights recorded in Plat Book "P" at Page 75 and being more particularly described according to said plat as follows:

BEGINNING at an iron pin in the southwestern side of Lander Street joint front corner of Lots 103 and 104 and running thence with the joint line of said lots S. 80-48 W. 262.9 feet to an iron pin; thence N. 47-56 W. 48 feet to an iron pin; thence N. 45-07 E. 62.6 feet to an iron pin rear corner of Lot 102; thence with the line of said lot N. 80-48 E. 240.6 feet to an iron pin the southwestern side of Lander Street; thence with said street S. 9-12 E. 72 feet to the point of beginning.

Being the same premises conveyed to mortgagor Louise C. Bowers by deed recorded in Deed Book 483 at Page 65, an undivided one-half interest having been conveyed to mortgagor Ralph Lee Bowers, Jr., by Louise C. Bowers, by deed to be recorded.

Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); all fixtures now or hereafter attached to or used in connection with the premises herein described and in addition thereto the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty and are a portion of the security for the indebtedness herein mentioned;
