NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the northern side of Pickens to Marietta Road, containing 2 acres, more or less, and having according to survey by W. A. Hester, April 28, 1944, the following metes and bounds, to-wit:

"BEGINNING at a stake in the Pickens Road, on the southeast line of the criginal $65\frac{1}{2}$ acre tract, in line of property of E. L. Robinson and running thence with line of said tract, N.61-30 W. 5.00 chains to a P. O. Stump (O.M.); thence N. 2-15 W. 4.00 chains to an iron pin; thence S. 61-30 E. 6.50 chains to an iron pin; thence S. 2-15 E. 1.90 chains to iron pin in Pickens Road; thence with said road S. 43 W. 1.71 chains to the beginning."
