"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Cantt Township, being known and designated as Lot 25 as shown on a map of Spring View recorded in Plat Book "BB" at Page 161, and being more particularly described according to said plat as follows:
