K. Keller as shown on a Plat thereof by W. J. Riddle, Surveyor, dated April 1948 recorded Plat Book U, page 97. Said property being a re-subdivision of the greater portion of Lots Nos. 23 and 24 of the Farr Estates Subdivision shown on a Plat thereof by Dalton & Neves, Engineers, dated July 1931 and recorded in the R.M.C.
