NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Townshin, on the Southern side of Farr's Bridge Road, said point being 210 feet Northwest from the corner of the tract of land heretofore conveyed to W. Lester Jenkins, and running thence with Farr's Bridge Road, N. 80-29 W. 69 feet to rin in bend; thence continuing with said road, N. 84-44 W. 54 feet to iron pin in line of other property of mortgagor; thence with line of said property, S. 24 W. 375 feet to iron pin; thence S. 65-20 E. 105 feet to pin in line of other property of mortgagor; thence with line of said property, N. 6-13 E. 404.2 feet to pin on Farr's Bridge Road; the point of beginning."
