# MORTGAGE

WHEREAS: I, James Preston Hudson

Greenville, South Carolina, hereinafter called the Mortgagor, is indebted to  
Fidelity Federal Savings & Loan Association

, a corporation organized and existing under the laws of United States of America, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Five Thousand and No/100 - - Dollars (\$5000.00), with interest from date at the rate of Four & One-Half per centum (4½ %) per annum until paid, said principal and interest being payable at the office of Fidelity Federal Savings & Loan Association in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Thirty-One and 64/100 Dollars (\$ 31.64), commencing on the first day of April, 19 55, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of March, 19 75.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville State of South Carolina; in Greenville Township, being known and designated as lot No. 102, Section 2, of the Dunean Mill Village, and being more particularly described according to a plat thereof recorded in Plat Book S at Page 175, as follows:

BEGINNING at an iron pin in the Western side of Wallace Street, at the joint front corner of lots 102 and 103, and running thence with joint line of said lots, N. 64-22 W. 132.9 feet to an iron pin in a 15 foot alley; thence with said alley, N. 24-36 E. 80.1 feet to an iron pin, rear corner of lot 101; thence with line of said lot, S. 64-22 E. 134.3 feet to an iron pin in the Western side of Wallace Street; thence with said Street, S. 25-38 W. 80.1 feet to the point of beginning.

Being the same premises conveyed to the mortgagor by deed to be recorded herewith.
