with interest from date at the rate of Five (5%) per centum per annum until paid; interest to be computed and paid monthly and if unpaid when due to bear interest at same rate as principal until paid, and we have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That we, the said Floyd E. Darnell and Hattie L. Darnell

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to us in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said First National Bank of Greenville, S. C. as Fiscal Agent for Thornwell Orphanage Retirement Fund, its successors and assigns,

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being near the line of Gantt and Greenville Township, situate, lying and being on the Dunham Bridge Road near Saluda River and being known and designated as a part of tract No. 13 and 12 as shown on plat made by Dalton & Neves, October 1932 and recorded in Plat Book "H", at pages 212 and 213 and being the same as shown by a Plat made by Pickell & Pickell, April 8, 1954 and having the following courses and distances:

BEGINNING at an iron pin at a point at the corner of W. B. Estes land, near the Old Dunham Bridge Road, and a Private Road, and running thence South 65-36 West 154.6 feet to an iron pin at the edge of said Private Road; thence running South 32-30 West 328 feet along edge of said Private Road to an iron pin at the line of the property of H. B. Mason; thence along the line of Mason property, North 63-09 West 164.5 feet to the line of the Stalling property at iron pin; thence N. 31-45 East 411.2 feet to an iron pin; thence along the line of W. B. Estes property, South 71-27 East 261.3 feet to the beginning point and containing 1-3/4 acres, more or less.
