NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, City of Greenville, being known and designated as Lot 13 as shown on a plat of North Meadow Heights recorded in Plat Book "W" at Page 183 and being more particularly described according to a recent survey prepared by R. W. Dalton, March, 1955, as follows:

BEGINNING at an iron pin in the northeast side of Cool Springs Drive which pin is 95 feet from the intersection of said drive and the Camp Road and is the joint front corner of Lots 12 and 13 and running thence with the northeast side of Cool Springs Drive N. 47-43 W. 80 feet to an iron pin corner of Lot 14; thence with the line of said lot N. 43-10 E. 199.7 feet to an iron pin corner of Lot 8; thence with the line of said lot S. 39-40 E. 35 feet to an iron pin corner of Lot 11; thence with the line of said lot S. 13-17 W. 84.3 feet to an iron pin corner of Lot 12; thence with the line of said lot S. 41-21 W. 120 feet to the point of beginning.

Being the same premises conveyed to the mortgagor by Greenville Home Builders, Inc., by deed to be recorded.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
