I. William M. Edwards hereinafter called

to be paid as therein stated

with interest thereon from maturity at the rate of 5 per centum per annum, to be computed and paid semi-annually until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agrees to pay all costs and expenses including a reasonable amount as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that lot of land in Chick Springs Township, State and County aforesaid, on the East side of Elaine Avenue on the North side of Super Highway No. 29 near Taylors, S.C. and designated as Lots No. 27 and 28 of the William M. Edwards property, original plat recorded in R.M.C. Office for Greenville County in Vol. page .

BEGINNING at an iron pin on the east side of Elaine Avenue and running S. 31-19 E. 133.4 feet along Elaine Avenue to an iron pin on corner of Lot No. 29; thence along lot No. 29 N. 58-41 E. 247.4 feet to an iron pin other corner of Lot No. 29; thence S. 29-07 E. 151.55 feet to an iron pin; thence S. 64.48 W. 242.4 feet to the beginning corner.
